2017 SCHOLARSHIP APPLICATION

ELIGIBILITY AND REQUIREMENTS

Eligibility: The James N. Kincanon Scholarship and the Jane S. Glenn Scholarship are available to students who demonstrate diligence in and commitment to their studies, academic excellence, and an interest in the pursuit of law.

The applicant must be a resident of the City of Roanoke, the City of Salem, or the County of Roanoke, or a graduate of a high school located in those jurisdictions, and must have a grade point average of at least 3.0 during high school (and college or law school, if applicable).

The James N. Kincanon Scholarship is available to students who have been accepted, or expect to be accepted prior to the 2017 fall semester, into post-secondary training, pursuing education in the law.

The Jane S. Glenn Scholarship is available to students who have been accepted, or expect to be accepted prior to the 2017 fall semester, into an accredited law school in the Commonwealth of Virginia.

Scholarship funds are sent directly to the educational institution.

Requirements: An original application, typewritten or completed in **BLACK INK**, which must be <u>postmarked</u> no later than March 31, 2017, and must be accompanied by the following:

- Two letters of recommendation <u>from non-family members</u>, dated during the current school year, one of which must be from a teacher or instructor. If recommendations are sent separately, they must be postmarked no later than March 31, 2017.
- A statement of 250 words or less on why the applicant has chosen to pursue an education in the law. **This personal statement will be extremely important in the selection process**. The selection committee reserves the right to interview applicants by teleconference or in person.
- An official copy of the applicant's latest grade transcript (3.0 GPA minimum required).
