

## **RESOLUTION OF APPRECIATION**

## MEMORIALIZING THE LATE ROBERT EASTWOOD GLENN

WHEREAS, Robert Eastwood Glenn passed away on October 18, 2018, in the presence of his children in the City of Roanoke, Virginia; and

WHEREAS, Bob was eighty-eight (88) years old at the time of his death; and

WHEREAS, Bob was born in Catlettsburg, KY and graduated from Radford High School in 1947, W&L University <u>cum laude</u> (B.S.) in 1951, and from W&L University School of Law (J.D.) <u>cum laude</u> in 1953; and

WHEREAS, Bob was commissioned in the United States Air Force where he served actively as a Judge Advocate in San Antonio, TX and Frankfurt, Germany and for many years thereafter in the Air Force Reserve, retiring at the rank of Lieutenant Colonel; and

WHEREAS, Bob began practicing law in Roanoke, Virginia in 1957 with the firm of Eggleston & Holton, predecessor to the current firm of Glenn Feldmann Darby & Goodlatte, and practiced full-time until his retirement in 2016; and

WHEREAS, Bob served his profession at various times as President of the Roanoke Bar Association, emeritus member of the Fourth Circuit Judicial Conference, Fellow of the American Bar Foundation, the Virginia Bar Foundation, and the Roanoke Law Foundation; member of the Virginia Board of Bar Examiners from 1982-1993 and as its President from 1993-2014; and

WHEREAS, Bob served his community at various times as President of the Roanoke Kiwanis Club, Chairman of the Roanoke City Republican Party, member of the Radford University Board of Visitors, including as its Rector, Chairman of the Roanoke Valley Chapter of the American Red Cross, member of the State Council of Higher Education, President of the Roanoke Regional Chamber of Commerce, member of the Virginia Foundation for the Humanities, a Director of the United Way of Roanoke Valley, and the Roanoke Symphony Society; and as President of the Shenandoah Club; and

WHEREAS, Bob traveled extensively and visited all of the forty-eight (48) contiguous United States and over forty (40) countries, but was most at home while enjoying lunch and a game of bridge with friends; and

WHEREAS, Bob is deemed by his children to have been an exceptionally attentive and affectionate father and a warm friend to many in the community; and

WHEREAS, Bob was preceded in death by his parents, Pauline Eastwood Glenn and Albert Sidney Glenn, and by his wife, Clydenne Reinhard Glenn; and

WHEREAS, Bob is survived by his children, Pauline Glenn O'Brien and her husband Paul Edward O'Brien of Doylestown, PA, and Robert Eastwood Glenn, Jr. and his wife Amelia Strobel of Nashville, TN, and four (4) grandchildren, Robert Francis O'Brien, Ellin Carley O'Brien, Patricia Sidney Glenn, and Elizabeth Braden Glenn.

NOW, THEREFORE, BE IT RESOLVED that the members of the Roanoke Bar Association hereby extend their deepest sympathy to the family of Robert Eastwood Glenn and hereby recognize his distinguished professional career and exemplary service to the Commonwealth of Virginia and the community of Roanoke, Virginia; and
