

## RESOLUTION OF APPRECIATION MEMORIALIZING THE LIFE OF THE LATE A. CARTER ("CHIP") MAGEE, JR.

WHEREAS, Chip died on February 14, 2019 in Roanoke, Virginia at the age of 64; and

WHEREAS, Chip was born to Dottie Magee and was raised in Roanoke, Virginia along with his sister Donna and his brother Rick; and

WHEREAS, Chip attended North Cross School, and then graduated from Hampden- Sydney College in 1976 and then from Washington & Lee School of Law in 1979, after which he was admitted to the Virginia State Bar; and

WHEREAS, Chip served as law clerk to the Honorable H. Clyde Pearson of the United States District Bankruptcy Court for the Western District of Virginia; and

WHEREAS, Chip began his practice of law at The Hazlegrove Firm; and

WHEREAS, Chip then formed Magee & Associates, which later became Magee, Foster, Goldstein & Sayers, (now Magee Goldstein Lasky & Sayers) for a distinguished legal career that spanned over 30 years; and WHEREAS, Chip chose to specialize in bankruptcy law, and became the preeminent bankruptcy attorney in Roanoke, well known and respected throughout the state and the Southeast; and

WHEREAS, Chip was a frequent lecturer to lawyers, bankers, and other business people across the Commonwealth on bankruptcy and insolvency topics; and

WHEREAS. Chip served as a professor of bankruptcy law at Washington & Lee School of Law for over 10 years, where he was a popular, well liked, and well-respected teacher; and

WHEREAS, Chip was highly regarded by his colleagues in the Roanoke Bar Association for his knowledge, tenacity and advocacy on behalf of his clients' interests; and

WHEREAS, Chip was ever available for advice and consultation to other lawyers on bankruptcy and insolvency issues; and was a man with many interests in life as an avid and highly skilled furniture restorer and story teller. He was most passionate about flying, and was an accomplished and enthusiastic pilot and airplane owner; and

WHEREAS, Chip was incredibly proud of his legal accomplishments and reputation, and the firm that he built; and

WHEREAS, Chip was even more proud of his family; frequently regaling his law partners with his childrens' skills and accomplishments; and WHEREAS, Chip loved an old pickup truck, which he spent countless hours restoring; and

WHEREAS, Chip is survived by his loving wife, Leslie; by son Carter, daughters, Julia and Caroline; and his brother Rick and wife Kathie.

NOW, THEREFORE, BE IT RESOLVED that the Roanoke Bar Association does hereby express its deepest sympathy to the family of Chip Magee and does hereby recognize his distinguished career and service to the public and to the Bar.
