COVID -19 ORDER #7

These Courts entered an order on March 16, 2020 to address emergency declarations of the President of the United States and the Governor of Virginia concerning the health and safety of our citizens,

And the Supreme Court of Virginia, by order entered March 16, 2020, declared a state of judicial emergency in all district and circuit courts of the Commonwealth of Virginia, and by orders entered March 27, 2020 and April 22, 2020 extended the judicial emergency through April 26, 2020 and through May 17, 2020 respectively,

And these Courts entered orders on March 16, 2020 (“First Order”), on March 30, 2020 (“Second Order”) and on April 10, 2020 (“Third Order”) to address the state of judicial emergency declared by the Supreme Court of Virginia and to clarify these Courts’ response to said emergency;

NOW, THEREFORE, based on the foregoing, it is **ORDERED** as follows:

1. The provisions of these Courts’ First, Second and Third Orders shall continue in full force and effect through May 17, 2020, as if fully set forth herein.
2. As expressly provided by the Supreme Court of Virginia in its order entered April 22, 2020, these Courts may, in the discretion of each presiding judge, hear any non-emergency or non-essential matters, upon agreement of all parties, attorneys and witnesses, by two-way electronic audio-visual communication system using a

secure communication platform such as Polycom or Webex, or by telephone.

Requests to participate by telephone should be liberally granted.

In any hearing conducted as herein provided, the Courts shall prohibit in-person gatherings of ten (10) or more individuals at all remote sites and require physical distancing at those sites.
